**CONDITIONS:**

1. At the time of admission, no any type of capitation fee Dan (Donation) or deposit can be levied by the Mandal of the School or by the School and cannot take the interview of child or of parents.
2. Admission cannot be denied in case child having no proof or evidence regarding age.
3. The assurance will be given by School that;
  - The child who admitted in the school and till completion of the primary education till then child cannot be kept in one class and cannot be debarred from the class or school.
  - No any child should be punished physically or mentally.
  - No Board examination to be given by the child till the completion of primary education.
  - The Certificate regarding completion of primary education will be given.
  - The appointment would be given to the Teacher who is eligible as per the provisions of Bombay Primary Education Act, 1947 and as per Rule of primary education, 1949.




